2015 FEM Electric Annual Meeting Minutes

The 67th Annual Meeting of the members of FEM Electric Association, Inc. was held at 6:30 p.m. at the Father Bormann Hall in Ipswich, SD on Tuesday, June 16, 2015 with 120 members registered.

An evening meal was provided to the members and guests after they registered. Frank Heinz called the meeting to order. Gary Bachman presented the invocation. Frank Heinz welcomed special guests, retired directors and retired employees. The National Anthem was presented via video and then the kids were dismissed to the children's program.

Secretary Larry Bowar declared that there was a quorum present to do business and he read the official notice of the meeting and proof of mailing. Frank Heinz entertained a motion to dispense with the reading of the minutes from the 2014 annual meeting and accept the minutes as distributed in printed form on page 3 of the annual report. Motion to approve was made, seconded, and carried.

Attorney Vaughn Beck introduced the Nominating Committee: James R. Goebel, Glenn Bode and Darrell Davis. The following candidates were nominated for re-election in District 5 – Larry Bowar. No petitions for nominations were turned in. Attorney Beck asked for a motion and a second to cast a unanimous vote to officially elect Larry Bowar for District 5, motion carried.

President Frank Heinz thanked Tom Boyko and Bob Gale from East River for attending the FEM Annual Meeting and assisting with the program. He also thanked the Holy Cross Alter Society for the meal. Frank then proceeded with presenting the President's Report. A review of the final costs from the 2010 ice storm was presented. The three energy bills that were introduced to state legislature were passed in 2014. The members were thanked for their support of grassroots efforts to address the EPA's 111d Clean Air Act. It is important that members stay involved and continue to support the issues that arise in the future. Basin Electric will be joining the Southwest Power Pool (SPP) which will allow Basin to buy and sell energy on the open market. This will open new markets in large cities to the south and east that use large volumes of energy. East River Electric is also studying the feasibility of joining the SPP. Frank reviewed the growth of kilowatt hour sales due to new construction of new shops,

houses and grain bins in our service territory. The new office building plan and construction was presented. Frank ended his presentation by thanking the staff at FEM and the members.

Vice President Gary Bachman introduced the guest speaker, Tom Boyko, General Manager at East River Electric Power Cooperative in Madison, SD. Tom explained to the members the relationship between them owning FEM Electric, who owns East River Electric, who owns Basin Electric. He encouraged them to remember that their relationship is very important and thanked the members for being involved. He also thanked Manager Scott Moore and East River Director Gary Bachman for representing the members at the East River level. He explained renewable energy and noted that 300 MW wind energy was added in 2014. Renewable energy makes up 40% of the current power supply. He touched on the SPP and the importance of this assisting in keeping the costs low and affordable. Load management saved \$175 million since 1985. Water heater legislation experienced a regulatory win. He thanked the members for signing EPA cards and sending them in to aid in the efforts regarding regulating carbon. Members were thanked for taking time to attend their annual meeting.

Treasurer Gerald Haupt stated that the bottom line is good. He announced the financial report was printed on pages 6-9 of the annual report handed out to all members at the beginning of the meeting. Gerald stated that all records have been audited by the firm Eide Bailly, LLP of Sioux Falls, SD. He gave a recap of 2014 stating the kwh sales increased to 151,301,130 and revenue is comprised of 67.3% commercial and 31.6% residential. The patronage capital and operating margin ended 2014 at \$690,853. He explained that financials remained strong during the URD rebuild project as we awaited FEMA reimbursement. The final FEMA funds were received in October 2014. The 2014 expense increases were reviewed. A recap of the line work completed in 2014 was presented and members were reminded it is our goal at FEM to maintain a strong system and always stay in touch with new technology while giving our members the best service possible. Most of all we want to stress that no matter what we do, safety comes first. A review of the non-operating margin was given along with a

brief synopsis of the partnership in North Star Energy and outsourcing our linemen to other coops. G&T allocations were explained and it was noted that FEM will be retiring \$218,615 in FEM capital credits for the years 1996, 1997 and partial year 1998. East River Electric has retired the balance of 1994 and partial 1995 in the amount of \$29,135. Basin Electric will not be retiring capital credits this year. Members were told to watch for their capital credits retirement on the July energy statement. All inactive members will receive a paper check towards the end of July. The members were told that the Department of Emergency Management has awarded FEM Hazard Mitigation Grant funds in the amount of \$655,836. Five projects in the amount of \$327,655 will be completed in 2015 and \$328,181 will be completed in 2016. Gerald also stated that the board and employees would like to thank the members for their patience over the past years and asked for continued patience and support as we complete upcoming system improvements. Our goal remains the same to continue the reliable service the members expect.

Prior to the Manager's report, Frank Heinz introduced the directors, General Manager Scott Moore and Attorney Vaughn Beck. General Manager Scott Moore thanked the members for taking time out of their busy schedules to attend their cooperative meeting. He stated that the General Manager report is on page 4 of the annual report. Scott stated that education is important for the staff, directors and youth to keep the understating of the cooperative model forefront and continually educate on the electric business. Scott shared a story from his youth which demonstrated that success is truly related to good organization, setting capable goals, good leaders and teamwork. He stressed the importance of getting the job done and doing it right. There are many teams at the coops on local, state and national levels. It is very important to keep up on the regulations to keep the rates low and competitive. Lobbyists worked hard in DC this year to help push back water heater regulations. Scott explained the water heater control program and the 5/7 load control program which help keep the demands of power down and contribute to saving millions of dollars. Managing load helps reduce the need for additional power plants being built. The director education plan was explained and the importance of our employees

providing top quality service was noted. Scott reminded the members of FEM Electric's mission statement

- To enhance the quality of life of our members, by safely providing reliable, cost-efficient electricity and other services. Teamwork is necessary for the success of the coop. The process for the building project at FEM was planned by a building committee. It is the goal of the committee for the building to be usable and conservative. Implementing technology costs money but it is important for FEM Electric and its members to move forward. We rely on the members' voice and votes when planning and managing FEM Electric. Scott ended by thanking the members for contacting the politicians when the need arises.

President Frank Heinz asked all employees to stand to be recognized and thanked for a job well done.

Tom Thorpe announced the 2014 Youth Excursion attendees Merciedies Dagett, Tonner Bowar, Cody Blocker, Frederick Lapka, Bailey Graham and Tori Moore. The Washington DC Youth Tour participants were Brandon Beutler, Jesse Weber, Joseph Kretchman, Tori Moore and Autumn Pitz. The \$1,000 Member Basin Scholarship was presented to Kristi Pond and the \$500 FEM Scholarships were presented to Sydney Hammrich and Francine Hoffman. Kristi Pond and Francine Hoffman were also recognized as 2015 Scholars of the Week. Tori Moore was recognized for winning a \$1,000 Employee Basin Scholarship.

Frank Heinz began the business part of the meeting by asking the members if they had any old business to discuss, there being none, he asked if there was any new business. There were no business items or questions brought up at the meeting.

At 7:15, a motion was made to adjourn the meeting, seconded and carried. The kids were asked to rejoin the adults for final prize drawings.

The Grand Prize Drawings were held: \$250 – Victor and Lila Gab, Eureka; \$100 – Leroy and Karen Neifer, Hosmer; \$100 – Leroy and Marlyn Ehnes, Roscoe; \$50 – Myron and Sheila Fauth, Leola. Gary and Betty Lou Hoffman from Long Lake were drawn for the 2015 Basin Trip. Megan Nash and Austin Nash were drawn respectively for the girls and boys bike giveaway.



The following FEM Electric Association, Inc. Bylaw changes will be voted on by the membership during the business portion of the FEM Electric annual meeting that begins at 6:30 p.m. on Thursday, June 16, 2016 at the Ipswich High School.

ARTICLE V MEETINGS OF DIRECTORS

Section 3. Notice of Director's Meetings. Written notice of the date, time, place and purpose of any special meeting of the Board of Directors shall be delivered to each Director not less than five (5) days previous thereto, either personally or by mail, by or at the direction of the Secretary, or upon a default in duty by the Secretary, by the President or the Directors calling the meeting. If mailed, such notice shall be deemed to be delivered when deposited in the United States mail addressed to the Director at the address as it appears on the records of the Cooperative with postage thereon prepaid. Notice may be provided by telephone and/or email of the date, time, place and purpose of any special meeting of the Board of Directors, which shall be communicated to each Director not less than three (3) days previous thereto, by or at the direction of the Secretary, or upon a default in duty by the Secretary, or upon a default in duty by the President or the Directors calling the meeting.

ARTICLE XI MISCELLANEOUS

Section 7. Assignment and Gift by Failure to Claim.

(a) Notwithstanding any other provisions of the bylaws, if any member or former member fails to claim any cash retirement of capital credits or their payment from the Cooperative within six (6) years three (3) years after payment of the same has been made available to such member by check mailed to the member at the last address furnished by the member to the Cooperative, such failure shall be and constitutes an irrevocable assignment and gift by such member of such capital credit or other payments to the Cooperative.

(b) Failure to claim any such payment within the meaning of this section shall include the failure of such member or former member to cash any check mailed to the member by the Cooperative at the last address furnished by the member to the Cooperative.

(c) The assignment and gift provided for under this section shall become effective only upon the expiration of six (6) years three (3) years from the date when such payment was made available to such member or former member without claim therefore and only after the further expiration of six (6) months sixty (60) days, following the giving of a Notice by mail or publication that unless payment is claimed within six (6) months sixty (60) days, such gift to the Cooperative shall become effective.

(d) The Notice by mail herein provided, shall be one mailed by the Cooperative to such member or former member at the last known address. If Notice by publication is given, such publication shall be one insertion in a newspaper circulated in the service area of the Cooperative.

(e) The six (6) month sixty (60) day period following the giving of such Notice, either by mail or publication, shall be deemed to terminate six (6) months sixty (60) days after the mailing or publication of such Notice.

Board President Report

Frank Heinz, Jr., Board President

2015 was another successful year for your cooperative by ending the year with a very good financial statement and an equity rate of 33.3%. The most exciting event was the completion of the new offices and truck bays. In October of 2013, the directors began discussing a new office complex and additional truck bays. Building and planning committees were assigned. After

much thought and consideration, the building project was approved. In December of 2014, a bid to Quest Construction was awarded and in March of 2015 the building process began. The open house on Dec. 10, 2015 was attended by many members and interested individuals from local communities. This has been an excellent addition to our cooperative. If you have not seen the new offices, please stop in, you will be impressed.

In June of 2015, FEM members received online access to their accounts through the FEM web site www.femelectric.coop. On this site, you can view and manage personal account information, pay your bill, view usage, print statements, receive notifications and alerts. This app works on Apple, Android and Windows.

In 2015 FEM, retired Capital Credits back to the members in the amount of \$246,365. The credit was given on your July billing statement. East River Electric also returned \$117,728 to FEM as a bill credit. In December, this amount was passed through to the members as a \$55 credit to each active main meter. In 2016, FEM will again retire Capital Credits in the amount of \$143,194.88. This credit will be given on your July billing along with \$30,301.11 of East River capital credits.

By the end of construction season December 2015, 37 miles of old overhead line was replaced with new line. 16 miles of old overhead was replaced with URD. Since March of 2016, the line crew has replaced 35

miles with new overhead poles and wire and 20 miles of old overhead was replaced with new underground line. They also did numerous upgrades, two of which were major upgrades at North Central Farmers Elevator, Bowdle and at Glacial Lakes Energy. As you can see, it has been an extremely busy year for the line crew and the office staff doing all the paperwork to make this possible.

As a non-profit corporation, sometimes people get the false impression that FEM does not pay taxes. This is not true. Under state law, electric companies are required to pay a generation tax based on kilowatt hour sales. FEM is also required to pay 2% gross receipts tax to cities in our territory, if a service is within city limits. This year the school districts in our area will receive \$467,340 in generation taxes as a result of electric kilowatt sales to FEM members. FEM also donates cases of water to the schools that they may use as fund raising activities.

EPA; On January 27th of 2016, Basin Electric along with 38 other electric coops and utility interests petitioned the Supreme Court to Stay the Clean Power Plan. A Stay was granted which means EPA cannot continue to enforce carbon dioxide limits of 32% below 2005 levels until the Supreme Court either takes up the case and issues a final decision, or denies a request to hear the appeal. Hopefully, the Supreme Court will decide to hear the case. An appeal would give the utility companies time, and depending on the final decision save billions of dollars. This in turn saves us, the members billions of dollars. Time will tell.

This is a brief overview of your cooperative the past year. At this time, on behalf of the board, I would once again like to say thank you to the great staff at FEM for all their hard work. To you the members thank you for your patience and support. May God bless you and keep everyone safe.

General Manager Report Scott Moore, General Manager /CEO

As I look back at the 2014 annual report where I discussed our electrical load growth and successes that year, both financial and operations, we turn the page to 2015.

In 2015, we have seen our electrical load growth stabilize or level out. We didn't see the big grain drying load and with a warmer than normal fall, our heating load was also down. With the decreased price of

grains and other commodities, the opportunity to not pay for grain drying will help keep our local agriculture economy strong.

FEM Electric had another good year financially; we continue to monitor changes in the electrical industry. Like most other industries, things are changing fast and the way we do business is also changing. In October of 2015, after several years of evaluating and studying, Basin Electric, our generating partner, along with East River, our transmission partner, joined the Southwest Power Pool (SPP). SPP is a Regional Transmission Organization (RTO) that was originally created for maintaining reliability and allowing access to the electrical grid in the south central part of the U.S. There are seven RTO's operating within the United States, and they control the dispatch of generators to produce power, and operate the transmission lines to transport the needed power to each region. RTO's were designed to administer open electric markets, enhance reliability, and manage access to the electric grid, creating opportunities to move power to areas during peak times and not forcing new generation to be built.

The problem the Midwest region has with this is that we have always had low cost power. Over the last seventy years, we have built base load generation using coal and hydro dams to serve our members with reliable power. In today's world, renewable power gets preference on the grid and each megawatt of renewable energy needs to be backed up with fossil fuel generation, which needs to be started and on the grid fast. This is most commonly done with peaking generator plants fueled by natural gas. Coal plants are designed to run at full capacity; once slowed down, it takes time to get them back to capacity and they lose their efficiency. Electric cooperatives have always had a good business model, but now we are learning to steer a new ship, while at the same time looking at opportunities to keep your power affordable. I can assure our members the electric cooperatives have people with the knowledge and dedication to move us through these rough waters.

On the operation side, FEM Electric had a very successful year replacing and rerouting about thirty-seven miles of single phase overhead electric line. We used over six hundred poles that were returned from the 2010 ice storm rebuild. The existing poles and wire were seventy years old and we rerouted some of the line to locate it next to traveled roads to make patrolling and repairing the line easier.

When the operation department is busy, so is the office moving the paperwork through the system. In 2015 the office participated in five audits, South Dakota Unemployment Insurance Audit, Sales and Excise Tax Audit, Annual Financial Audit with Eide Bailly, Workers Comp Insurance Audit, and Rural Utilities System Audit (RUS).

As manager/CEO of FEM Electric, I would like to thank our employees and board for working together. Working as a team we have created an efficient, knowledgeable group that will successfully serve FEM Electric members well into the future.

Treasurer's Report



Gerald Haupt, Treasurer

It is my pleasure to provide you with the financial statements for 2015. All records were audited by the firm of Eide Bailly, LLP of Sioux Falls in March 2016.

FEM's total utility plant at the end of 2015 was \$32,285,724 and we have

depreciated \$7,572,107 which leaves \$24,713,617 in un-depreciated plant. We had investments and cash on hand in the amount of \$6,046,366 which includes capital credits due from power suppliers and other organizations with which we do business. Other assets, which includes inventory, accounts receivable, prepaid accounts and other partnership investments were \$2,729,802. **Total assets for 2015 were \$33,489,785.**

On the other side of the ledger, "What We Owe" includes notes due to the Rural Utilities Service (RUS) and other lenders in the amount of \$18,971,612. The construction for a new office building and shop expansion began in the spring of 2015, the construction line of credit had a balance of \$2,055,000 at the end of December 2015. Accrued tax expense, customer deposits, notes payable and deferred credits were \$1,666,175. Patronage capital and other equities, which are primarily the margins generated by your cooperative since 1998, were \$10,796,998. The total liabilities and equities were \$33,489,785.

On page 9, you will find the Income and Expense Statement for 2015. **Total operating income for 2015 was \$13,519,471** which is down \$220,242 from 2015. Revenue from residential customers was \$4,089,571 and revenue from commercial customers was \$9,257,534.

Total expenses were \$12,971,734, which included power costs of \$8,936,215 at a decrease of \$41,147. Operations and maintenance expenses were \$998,567, a decrease of \$83,678. Customer services, sales, and office expense was \$1,300,257, a decrease of \$30,784. Depreciation expense was \$804,627, which was an increase of \$77,660. In 2015 a depreciation rate review was done and depreciation rates were adjusted to account for the 2010 storm rebuild adjustments to plant. Tax expense was \$242,932, which was an increase of \$1,033. Interest expense was \$688,772 which was an increase of \$255. The interest expense on the storm line of credit was \$2,670 which was a decrease of \$89,385. The storm line of credit was paid off in February 2015 and the balance was converted to long term debt.

FEM's patronage capital and operating margin was \$547,737. Non-operating margin and income from investment in North Star and Rural Dakota were \$205,607. See page 14 for more information on North Star Energy and Rural Dakota. East River and other margins, which are capital credit allocations from other cooperative organizations which we do business with were \$350,789. The total margins were \$1,158,005.


In 2015, the Commercial revenue increased and is 68.5% and residential decreased and is 30.2%. On page 7, you will find a comparison of various operating statistics for the calendar years 2014 and 2015. **Sales were decreased 320,821 kWhs and the number of connected meters increased by 2 for a total of 2,137.** The average monthly residential usage decreased 145 kWh and the average monthly residential bill decreased by \$12.08. Also included are a number of graphs that show the breakdown of revenue and expenses for 2015 and also chart our history for the last five years.



Comparative Operating Statistics



Miles of Line







Revenue Allocation





North Star Energy, LLC

Energy LLC The propane market in 2015 was low along with the amount of propane sold. In 2015 North Star Energy sold 660,000 gallons less than the previous yearend. With a lack of crop drying and an unusually warm winter, sales were down and propane inventories were up. North Star is financially strong and is an asset to FEM members and this region.

The board and exceptionally dedicated employee group are committed to providing quality customer service along with safe, affordable propane. In the fall of 2015 the board approved hiring Gary Goeller, Account Manager. Gary has been out meeting with existing and new customers, which is a must in the retail business. Propane is a very competitive business, and North Star management has done a great job of looking for savings along with looking for programs that would benefit our customers.

You may have noticed that North Star is moving into Propane Auto Gas. In the coming years it is the company's goal to get more vehicles using propane as a fuel choice. The motors need gas to start and they automatically switch to burning propane. FEM Electric plans to have three vehicles running on propane by the end of 2016. At the present time North Star has two card troll filling locations, at the main office in Aberdeen and at the FEM Electric parking lot in Ipswich. You will also see more cylinder cages in the area at local businesses.

In 2004 FEM Electric along with Valley Telco, and North Central Farmers Elevator, formed Rural Dakota Development. This group developed a housing development on the west side of Ipswich, Golf View Acres. Originally there were twenty-nine lots for sale and as of December 31, 2015 Rural Dakota has nine lots left to sell. Currently there are eight houses in the development that FEM Electric serves power too. FEM's total investment was \$95,000. As of December 31, 2015 FEM Electric has received a return on investment of \$46,300 and has \$47,387 in equity.





Water Heater Rebates

Consumers installing electric water heaters will receive the following rebates; non-lifetime heater, 50 gallons or larger, \$3.00 per gallon; lifetime units 50 gallons or larger will receive a \$6.00 per gallon rebate. To be eligible for a rebate for an electric water heater, the unit must have a load control receiver installed. There is no cost for installation of the load control receiver. By having load control hooked to your water heater, you will also enjoy \$5.00 off your monthly electric bill. Call FEM Electric at 426-6891 for more information.
